Age Policy

- All members must be **18 years or older** to attend classes and sign this waiver.
 - Minors aged **16–17** may participate only if accompanied by a parent or legal guardian who signs the required waiver.
 - Individuals under **16 years of age are not permitted** in the studio under any circumstances.

PURCHASE POLICY

- Classes, instructors, and schedules are subject to change without notice.
 - All purchases are **non-transferable and non-refundable**.
 - Expiration dates are listed on purchase receipts.
 - The Company is not responsible for bank or overdraft fees.
 - Approved refunds (if any) will incur a **\$25 processing fee**.

CLASS ATTENDANCE POLICY

- Members must arrive **at least 10 minutes prior** to class start time.
- Entry is not permitted once class begins. Late arrivals (5+ minutes) will be considered a **no-show**.
- No-shows and late cancellations will incur a **\$40 fee**.

Cancellation Policy:

- Classes must be canceled **at least 12 hours in advance** via the app or website.
 - Late cancellations result in:
 - Loss of class credit
 - \$40 + tax fee

CANCELLATION & FREEZE POLICY (MONTHLY MEMBERSHIPS)

- Memberships require an initial **three (3) month commitment**.
- After the initial term, memberships renew automatically until canceled.
- Cancellation or freeze requests must be submitted **at least 7 days prior** to the next billing date.

Freeze Policy:

- Maximum of **2 freezes per year**, not exceeding **2 months total**
- Freeze requests must be submitted in writing with exact dates
- Freezes do not extend billing cycles but preserve remaining time
